Accessibility statement

Financial Supervisory Authority (FIN-FSA) is committed to making its reporter portal accessible in accordance with the [Act on the provision of digital services 306/2019](#).

This accessibility statement applies to the system for reporting the financial standing and risks of supervised entities.

Compliance status

This system is partially compliant with the Web Content Accessibility Guidelines version 2.1 AA standard, due to the non-compliances listed below.

Non-accessible content

The content listed below is non-accessible for the following reason: Non-compliance with the Act on the provision of digital services 306/2019.

Visual accessibility

- The contrast between text and background colours as well as between user interface elements or meaningful graphical elements and background is insufficient in numerous elements. (WCAG 1.4.3, 1.4.11)
- Sometimes information is presented with colour only, causing problems for colour-blind users. (WCAG 1.4.1)
- Some functionalities and contents can't be used at all on a portrait mobile screen or on a 320 CSS pixel wide screen. (WCAG 1.3.4, 1.4.10)

Keyboard accessibility

- Most interactive elements (e.g. links, buttons and form elements) can't be entered using only a keyboard. (WCAG 2.1.1)

- Keyboard focus gets trapped in the calendar element and message field of the New discussion. (WCAG 2.1.2)
- Many interactive elements lack a visible focus indicator. (WCAG 2.4.7)
- The different views of the system lack unique titles and newly opened pages are not added to browser history. Keyboard focus is not set to the beginning of the newly opened view automatically. (WCAG 2.4.2, 2.4.3, 4.1.3)
- The system doesn't have a "Skip to main content" link. Also, the main content hasn't been marked with a <main> landmark or with a h1 level heading. (WCAG 2.4.1)
- Keyboard focus gets lost behind modal dialogs. (WCAG 2.4.3)

Structure

- All the pages in the system are missing a clear heading structure. (WCAG 1.3.1)
- The lists in the system are not marked as lists semantically. (WCAG 1.3.1)
- The tables in the system have been implemented as two separate tables and therefore a screen reader reads the table heading row twice. (WCAG 1.3.1)
- All the main content is presented inside iframe elements. These iframes lack accessible names (titles). (WCAG 2.4.1, 4.1.2)
- Several visual buttons or icons lack a descriptive text alternative. (WCAG 1.1.1, 4.1.2)
- Some sections on the pages miss programmatic landmarks. (WCAG 2.4.1)

- The language of the main content iframe elements has not been set. It is possible to set some of the user interface elements' language to Finnish or Swedish which results in a mixed language user interface. The language of different elements hasn't always been set correctly. (WCAG 3.1.1, 3.1.2)
- HTML code includes nesting errors and duplicate ID's. (WCAG 4.1.1)
- Excel validation reports include accessibility issues: table header cells are missing header markup, there are numerous contrast issues, document title is missing, and merged cells might cause problems with the logical reading order of the tables. (WCAG 1.3.1, 1.4.3, 2.4.2, 2.4.3)

Navigation

- Main navigation is not accessible to keyboard and screen reader users. The main navigation has not been marked as a navigation element and its links are not presented as a list. Decorative icons have unnecessary text alternatives. (WCAG 1.1.1, 1.3.1, 2.1.1, 2.4.4, 4.1.2)
- The status of an active or selected element is not determined programmatically in the system e.g. in the main menu, filters, discussions, tabs, calendar element and pagination elements. (WCAG 1.3.1)
- The system provides contents that appear on mouse hover (e.g. tooltips and main menu). These contents cover other content, but they can't be closed with Esc key. Also, the External links submenus close too easily when the user tries to move the pointer to them. (WCAG 1.4.13)
- Many of the pages in the system can only be found on the homepage since they can't be accessed through the main menu. (WCAG 2.4.5)

- Screen reader users are not notified of announcements and feedback messages automatically without having to change focus. (WCAG 4.1.3)
- The tabs have not been implemented as buttons and their type has not been communicated to screen reader users. The tabs can't be used with a keyboard. (WCAG 1.3.1, 2.1.1, 4.1.2)
- The user is not notified before the session timeout. Also, the user can't remove the time limit, adjust it or continue the session. (WCAG 2.2.1)
- It is not communicated to the user in advance, if a link opens in a new window or if it opens a PDF file. (WCAG 2.4.4)

Form elements

- Labels of the form elements have not been programmatically connected with the form elements. In addition, some form elements are missing a label altogether. (WCAG 1.3.1, 2.4.6, 3.3.2)
- Form groups are not grouped programmatically, and the visible group label is not connected to the group e.g. in radio button groups. (WCAG 1.3.1)
- The required form fields are not marked in any way. (WCAG 3.3.2)
- In New discussion, an inactive Send button is used as feedback when mandatory information is missing. (WCAG 1.3.1, 3.3.1)
- Inline error messages are not read automatically by screen readers as they appear. Also, error messages are not programmatically associated with the fields. (WCAG 3.3.1, 4.1.3)
- In the settings, input meant for personal information has not been marked with autocomplete attribute. (WCAG 1.3.5)

- Element type and state are not communicated to screen reader users in some cases (e.g. filters and checkboxes). (WCAG 4.1.2)
- The calendar element is not accessible to keyboard and screen reader users. Also, it is not possible to input the date in any other way. (WCAG 1.1.1, 1.3.1, 2.1.1, 2.4.6, 4.1.2)
- In the settings, action buttons are only presented at the top of the page. The buttons can't be used with a keyboard. (WCAG 2.1.1, 2.4.3)
- "Filter by date" selection sets the keyboard focus unexpectedly at the top of the page. (WCAG 3.2.2)

Content

- In the instructions of the system, text sometimes only refers to the visual location of the element. (WCAG 1.3.3)
- The instructions of the system are presented in a PDF user guide which has some accessibility issues. The document doesn't have a title or bookmarks. All the images are missing an alternative text, or they haven't been marked as decorative. Also, the primary language has been set to English in all language versions. (WCAG 1.1.1, 2.4.2, 2.4.5, 3.1.1)

Preparation of this accessibility statement

This statement was prepared on 28 March 2024.

The statement is based on a third-party assessment of whether or not the website meets the requirements of Directive (EU) 2016/2102.
